


YOUR VOTE MATTERS - AAUW ELECTION

Education Requirement for AAUW

Don't forget that AAUW members have been asked to vote to elect members to the national board of directors and on amendments to our Public Policy Priorities and bylaws. A direct link to vote was emailed to you on April 7 with your member id and PIN.

The ballot includes proposal to eliminate AAUW's longstanding membership degree requirement. This proposal is supported by state and national AAUW as a way to better LIVE our mission, vision and values saying that others perceive AAUW as • Elitist • Out of touch with cultural change • Not honoring the value of inclusion • Weaker without all our allies • Not willing to partner with others....

We had a lively discussion about this at our last meeting. All members should look closely at the proposal and vote the way you fell. This month, our hearts are both heavy and hopeful. On April 15, 2021, the House of Representatives voted 217-210 to pass the Paycheck Fairness Act with bipartisan support.
